SCHEDULE 13D

This Amendment No. 1 to Schedule 13D (this "Schedule 13D/A") amends and supplements the statement on Schedule 13D originally filed with the Securities and Exchange Commission on April 24, 2017 (the "Schedule 13D"), with respect to shares of the common stock, par value \$0.01 per share ("Common Stock"), of Runway Growth Credit Fund Inc. (f/k/a GSV Growth Credit Fund Inc.), a Maryland corporation (the "Issuer"). The address of the principal executive office of the Issuer is Runway Growth Credit Fund Inc., 2925 Woodside Road, Woodside, CA 94062. Unless otherwise indicated, each capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the Schedule 13D. From and after the date hereof, all references in the Schedule 13D to the Schedule 13D or terms of similar import shall be deemed to refer to the Schedule 13D as amended and supplemented by this Schedule 13D/A.

Item 3. Source or Amount of Funds or Other Consideration

Item 3 of the Schedule 13D is amended and supplemented by adding the following information to Item 3:

Pursuant to a capital call by the Issuer on June 12, 2017, each of Carilion Clinic and the Retirement Plan purchased 181,888.53 shares of Common Stock of the Issuer in exchange for consideration from each of approximately \$2,728,328 (\$15.00 per share) pursuant to the Subscription Agreements.

Item 5. Interest in Securities of the Issuer

Item 5(a) of the Schedule 13D is hereby amended and restated to read as follows:

- (a) As of June 15, 2017:
 - (i) Carilion Clinic may be deemed to beneficially own 332,444.6 shares of the Issuer's Common Stock, representing 11.08% of the outstanding shares of the Issuer's Common Stock; and
 - (ii) the Retirement Plan may be deemed to beneficially own 332,444.6 shares of the Issuer's Common Stock, representing 11.08% of the outstanding shares of the Issuer's Common Stock,

in each case, based on 3,001,667 shares of the Issuer's Common Stock outstanding as of June 15, 2017, as provided to the Reporting Persons by the Issuer.

The Reporting Persons may be deemed to constitute a "person" or "group" within the meaning of Section 13(d)(3) of the Act. The filing of this Schedule 13D shall not be construed as an admission of such beneficial ownership or that the Reporting Persons constitute a person or a group.
